With a successful 45-year track record of financing consumer, small producer, housing, and worker-owned cooperatives, Shared Capital's mission is to build a just, equitable, and democratic economy by investing in cooperative enterprises. Shared Capital is a cooperative association that is democratically owned and governed by 300 cooperatives throughout the US.

#### **POSITION SUMMARY**

This position is responsible for originating and underwriting small business and commercial real estate loans to cooperatives; for providing service, technical assistance, and resources to borrowers; and to provide staff, committee, and board members with accurate and timely borrower data for decision making regarding loan-related actions. To perform this job successfully, you must be able to carry out each job function satisfactorily.

### **POSITION RESPONSIBILITIES**

# Assist startup and expanding cooperative businesses gain access to needed capital by:

- Underwriting loans to cooperative businesses.
- Delivering technical assistance and advice to cooperative organizers, managers, board members, to help them plan for and support their long-term business success.
- Appropriately structuring loans, negotiating terms, and coordinating with local and national lending partners, including banks, credit unions, and other CDFIs.

#### Growing Shared Capital's loan portfolio while managing its risk of loan loss by:

- Conducting due diligence and credit analysis on potential borrowers during the underwriting
  process and preparing credit memos to present recommendations to staff lending team, loan
  committee, and board of directors.
- Cultivating and developing lending opportunities to meet lending and impact goals through outreach and engagement of members, prospects, cooperative developers, and partners.
- Monitoring the performance of borrowers, tracking financial performance and compliance.
- When needed, managing workouts, defaults, dissolution, and/or bankruptcy to support the success of the business, where possible, and to ensure the repayment of loans.

# Keep customer satisfaction and retention at high levels by:

• Maintaining a high-touch and personalized relationship with prospective borrowers throughout the loan application and borrowing process.

#### Contribute to Shared Capital's positive reputation in the marketplace by:

- Representing Shared Capital and making public presentations about the organization, cooperative lending, and finance at regional and national events and conferences.
- Developing and delivering engaging and effective workshops and presentations.

- Strong financial aptitude and financial analysis skills.
- Ability to work effectively and build respectful relationships with people of diverse cultures and backgrounds.
- Ability to be self-directed, effectively organize priorities, and manage multiple projects.
- Collaborative and committed to working as a part of a team.
- Excellent verbal and written communication skills.
- Knowledge of cooperative business models.
- Willingness and ability to travel regularly.
- Spanish language proficiency a plus.
- Exceptional customer service and interpersonal skills.
- Knowledge of, and ability to use computer and other technical resources to effectively accomplish work; advanced skill in Microsoft suite of products is essential; experience with lending and investing software is important; experience with TEA is ideal.
- Commitment to social and economic equity and justice, and to the mission and values of the cooperative.
